Wetland 1 is located in a depressional area surrounded by a public road to the north and west and commercial development to the south and east with no surface water connection to a downstream water. The Dakota County Soil Survey describes the surrounding soil as urban land. The closest tributary is an unnamed stream approximately 2,250 feet northeast of Wetland 1. Wetland 1 is on a terrace at least 30 feet in elevation above the unnamed stream. Wetland 1 does not abut a TNW, lake, pond, or impoundment of a jurisdictional water in a typical year; and is not inundated by flooding from any waterbody. Therefore, Wetland 1 does not meet the definition of an adjacent wetland under the NWPR and is not a waters of the US.
