Wetland A is located in a depressional area surrounded by residential open space with no surface water connection to a downstream water. The closest tributary as shown on the USGS Topographic map is more than 1 mile from Wetland A. Wetland A is bordered by a railroad corridor to the west. The closest surface water feature as identified by USGS Topographic Map is Gun Club Pond approximately 160 feet south of Wetland A. In an approved jurisdictional determination dated March 18, 2008, Gun Club Pond was determined to be hydrologically isolated. The delineation of Wetland A includes an excavated channel that extends approximately 100 feet to the south to a storm water pond that was constructed in upland. Wetland A does not abut a TNW, lake, pond, or impoundment of a jurisdictional water in a typical year; and is not inundated by flooding from any waterbody. Therefore, Wetland A does not meet the definition of an adjacent wetland under the NWPR and is not a water of the U.S.
