These wetlands are located in depressional areas along Runway 2/20 of the Rochester International Airport and are surrounded by open space with no surface water connection to a downstream water. The closest tributary as shown on the USGS Topographic map is an unnamed stream approximately 600 feet southeast of Wetland 3. These wetlands are approximately 16 feet in elevation above the unnamed stream and are separated by an upland ridge approximately 5 feet higher in elevation and a grassed area maintained as part of the airport operation with no evidence of surface water connection. These wetlands do not abut a TNW, lake, pond, or impoundment of a jurisdictional water in a typical year; and are not inundated by flooding from any waterbody. Therefore, these wetlands do not meet the definition of an adjacent wetland under the NWPR and are not waters of the US. Wetlands 1, 2, and 3 are ditches constructed along an airport runway. No wetlands or tributaries were present in the area prior to the construction of the ditches.
