Based on a review of aerial photographs, Wisconsin Wetland Inventory, NRCS hydric soils map, and Milwaukee County elevation contours, W-2 is a shrub-carr depression surrounded wholly by upland. There are no inlets or outlets other than overland sheet flow. The closest tributary is Lincoln Creek, approximately 2,400 feet to the west and over 20 feet lower in elevation, meaning that W-2 would not be flooded by an a(1)-a(3) water in a typical year. There are no natural berms, banks, dunes, or similar natural features physically separating W-2 from an (a)(1)-(a)(3) water, and it is not physically separated from an (a)(1)-(a)(3) water by an artificial dike, barrier, or similar artificial structure.
W-1A W-1B	0.024 0.007	acre(s)	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1).	These features are roadside ditches that were constructed in upland to convey localized runoff. Based on aerial photography, ground level site photographs, Wisconsin Wetland Inventory, and topographic maps, these ditches carry no more than ephemeral flow and do not relocate a tributary, are not constructed in a tributary, and are not constructed in an adjacent wetland.
