These roadside ditch wetlands (as confirmed by the delineation of aquatic resources and historical photos) are in concave depressions. They are not TNWs or (a)(2) waters; they were not constructed in or relocate a tributary, or were constructed in an adjacent wetland and satisfy the flow conditions of the tributary definition; and they were not constructed in an adjacent wetland and developed wetland characteristics. Therefore, Wetlands 1, 2, and 3 are not considered to be waters of the U.S. and are not jurisdictional under Section 404 of the Clean Water Act.
