Wetland 2	0.21	acre(s)	(b)(1) Non-adjacent wetland.	The wetland delineation report and Washington County 1-foot elevation map indicate that Wetland 2 is located within a concave ditch near the 873-foot elevation. This wetland has several inlets and receives runoff from surrounding uplands. According to Washington County GIS, the closest mapped tributary is an unnamed tributary to the Menomonee River located over 2,460 feet away feet and 6 feet higher in elevation. Based on the elevation difference and the distance away from the closest tributary, surrounding development, and location within an area of minimal flood hazard, W-2 would not be flooded by an (a)(1)-(3) water in a typical year. This wetland does not abut one point or side of an (a)(1)-(3) water. There is no natural or artificial berm, bank, dune or similar feature that is physically separating this wetland from an (a)(1)-(3) water.
