Wetland 4	7.69	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 4 is an isolated depressional, seasonally flooded basin and depressional area (shallow marsh) with no natural or constructed outlets. There is a topographic elevation rise around the wetland complex.
Wetland 5	0.44	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 5 is an isolated depressional area (shallow marsh) with no natural or constructed outlets. There is a topographic elevation rise around the wetland complex.
Wetland 6	0.02	acre(s)	(b)(1) Non-adjacent wetland.	Wetland 6 is an isolated depressional, seasonally flooded basin with no natural or constructed outlets. There is a topographic elevation rise around the wetland complex.
