Based on aerial photographs and topographic contours, W-1 is a drainage swale depression surrounded by upland consisting of a gravel road and an agricultural field. It is not clear if the wetland existed before construction of the gravel road (some of W-1 is in partially hydric soil). There are no inlets/outlets other than overland sheet flow. The closest tributary is unnamed to the Milwaukee River, over 2,500 feet to the northwest and over 60 feet lower in elevation (~790' to 850'). W-1 is also in FEMA's area of minimal flood hazard; therefore, it would not be flooded by an (a)(1)-(a)(3) water in a typical year. There are no artificial or natural barriers separating W-1 from a water of the U.S.
