Additional comments to support AJD: The review area for this determination is limited to the delineated boundaries of 13 wetland area labeled as: W-3B, W-4A, WD-4B, WD-4C, WD-4D, WD-5A, WD-6C, WD-9D, WD-9E, WD-9G, WD-9H, WD-11A and WD-11B on the attached figures labeled 2020-02515-CCK AJD Attachments, Pages 2-4; and does not include other waters on site. The total area of non-jurisdictional waters within the review area is approximately 1.01 acres of wetlands.

The specified wetlands listed above within the review area meet the definition of "wetlands" under paragraph (c)(16) and are not (a)(4) waters because they do not meet the definition of "adjacent wetlands" under paragraph (c)(1). W-3B, W-4A, WD-4B, WD-4C, WD-4D, WD-5A, WD-6C, WD-9D, WD-9E, WD-9G, WD-9H, WD-11A and WD-11B were constructed in uplands to convey runoff form the adjacent roadway, and are now linear wetlands that meet the definition of "ditch" under paragraph (c)(2). In addition, the ditches are not (a)(1) waters, are not relocated tributaries, are not constructed in a tributary, and are not constructed in an adjacent wetland. All of these wetlands are linear wetlands parallel to an existing roadway and do not extend beyond the delineated proposed construction ROW area(s), based off NWI maps, topo maps and aerial photos.

This was confirmed by reviewing aerial photography, national hydrography data, and topographic data. Based on this review, the assessed ditches are not jurisdictional under the NWPR because they meet the requirements of the exclusion for ditches under paragraph (b)(5).
