Review of the LiDAR 2-foot contour map submitted in the wetland delineation report show that the wetland is surrounded by upland. Additionally, review of Google Earth images do now show a surface water connection to an a(1)-a(3) water. Based on this information, Wetland 1 lacks adjacency to an a(1)-a(3) water and is therefore not a water of the U.S. under the Navigable Waters Protection Rule. |
