Wetland 1	1.09	acre(s)	(b)(1) Non-adjacent wetland.	Wetlands 1, 2, 3, 4, 5, 6, and 7 are located in depressional areas and do not abut at least one point or side of, a paragraph (a)(1)-(3) water. Based on USGS, FEMA maps and elevation contours, the wetlands would not be flooded by an (a)(1)-(3) water in a typical year. NHD and NWI maps confirm no surface hydrological connections to the wetlands from an (a)(1)-(3) water. There is not a natural berm, bank, dune, or similar natural feature physically separating the wetlands from a paragraph (a)(1)-(3) water. They are not physically separated from a paragraph (a)(1)-(3) by an artificial dike, barrier, or similar artificial structure. Based on this information, the wetlands do not meet the definition of an adjacent wetland under the NWPR and are not waters of the US.
