Wetland 4	0.022	acre(s) (b)(1) Non-adjacent wetland.	<p>The review area consists of agricultural land and vacant residential property. The soils series is Horton silt loam (HrB) a predominantly non-hydric soil series. The topography of the review area is relatively flat, <1 ft change in elevation across the review area.</p> <p>Based on aerial photography, photos submitted in the wetland delineation report, and the topography around Wetland 4, we have determined that Wetland 4 is an isolated depression whose boundaries do not extend outside the review area and transition into uplands within the review area. Wetland 4 does not abut an a(1)-a(3) water and is not separated from one by any man-made or natural feature.</p> <p>The closest mapped stream is an unnamed tributary to Bear Creek approximately 134 feet southeast of the of the review area. The tributary is classified as intermittent with no mapped floodplain within an area of minimal flood hazard. Onsite photos indicate that the tributary is moderately entrenched due to previous manipulation and channelization. Wetland 4 is outside the tributary's potential flood plain eliminating the likelihood of this feature being flooded in a typical year by an (a)1-a(3) water.</p>
