Additional comments to support AJD: **Wetland is an isolated depressional, seasonally flooded basin with no natural or constructed outlets and has a topographic elevation rise around the wetland complex. The wetland is not an adjacent wetland to (a)(1), (a)(2), (a)(3) WOTUS, and is not contributing to a surface water flow directly or indirectly to an (a)(1) water, and is not inundated by flooding from an (a)(1)-(a)(3) water in a typical year.**

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
