Wetland 1	0.5	acre(s)	(b)(1) Non-adjacent wetland.	The subject water does not meet the definition of “adjacent wetlands”. A review of available resources confirmed the wetland investigated is located within an enclosed depression that has no surface water connections to intermittent or perennial tributaries. The investigated wetland is physically removed from the nearest A(1)-A(3) water, and there is no evidence that it is directly abutting an A(1) – A(3) water. The investigated wetland was determined to be hydrologically isolated and is therefore not regulated by the Corps under Section 404 of the Clean Water Act. See III C for additional information.

C. Additional comments to support AJD: Wetland 1 is located within an enclosed depression (confirmed via site photos and USGS quad map); this area was previously logged in ~2016. A small drainage ditch is connected to Wetland 1, terminating in upland/cropped fields to the northeast and near a farmstead located to the southwest. This drainage ditch appears to be a natural feature on the landscape and has no surface water connection to any intermittent or perennial tributaries.
