This determination is for an approximately 1,306 linear foot portion of man-made drainage ditch and approximately 5 acres of prior converted cropland proposed for drain tile installation. Based on a review of the Wisconsin Wetland Inventory, USGS Topographic Map, USDA-NRCS Soil Survey, and USDA certified wetland determination, the entire 1,306 linear foot reach of man-made drainage ditch was not constructed in an adjacent wetland and is not a relocated natural tributary. The proposed 5-acre drain tile area would be located in prior converted cropland per the USDA certified wetland determination for Farm 21557, Tract 15108. Accordingly, the man-made drainage ditch is not a tributary under the NWPR and the prior converted cropland is excluded from Section 404 jurisdiction under the NWPR.
