This determination is for an approximately 1,800 linear foot portion of man-made drainage ditch and approximately 6.45 acres of mapped wetland. Based on a review of the Wisconsin Wetland Inventory, USGS Topographic Map, USDA-NRCS Soil Survey, and USGS National Hydrography Data, the entire 1,800 linear foot reach of man-made drainage ditch was not constructed in an adjacent wetland and is not a relocated natural tributary. The 6.45 acres of mapped wetland are adjacent to the unnamed drainage ditch, but situated approximately 1,500 linear feet away and separated by uplands to another waterway located to the northwest. Accordingly, the man-made drainage ditch is not a tributary under the NWPR and the 6.45 acres of wetlands do not meet the NWPR requirements for adjacency.
