The feature was constructed in non-hydric upland soil during the same timeframe that construction development was occurring to the south of the project. No waterway or wetland was found on historical USGS, NHD, NRCS maps at the site location. There is a large stormwater outlet into the pond. The feature is a stormwater pond that was excavated in upland. Based on this review, the feature is not jurisdictional under the Navigable Water Protection Rule and the Clean Water Act.
