			Wetland 1 does not abut an a(1)-(3) water and isn't inundated by flooding from an a(1)-(3) water in a typical year. Wetland 1 is not separated from an a(1)-(3) water by a natural or artificial feature nor does it have direct hydrological surface connection in a typical year. Wetland 1 is completely surrounded by upland. The site is lower in elevation than the surrounding area. The nearest a(1)-(3) water, Little Lake Butte des Morts, is approximately 1,600 feet north and there is an elevation change of over 18 feet between the two features. The flood zones for the nearest a(1)-(3) feature is mapped, the zone is not within or near the AJD Review Area.
