Wet Ditch's 1b, 2b, 2c, 5b, 6b, and 8b were constructed in uplands to convey runoff from the adjacent roadway and forested areas, and are now linear wetlands that meet the definition of "ditch" under paragraph (c)(2). In addition, the ditches are not (a)(1) waters, are not relocated tributaries, are not constructed in a tributary, are not constructed in an adjacent wetland and were not constructed in an (A)4 water at the time they were constructed. This was confirmed by reviewing aerial photography (See 1969 Historic Imagery), national hydrography data. Based on this review, the assessed ditches are not jurisdictional under the Navigable Waters Protection Rule because they meet the requirements of the exclusion for ditches under paragraph (b)(5)
