Explain: **The 13101 Lever Street NE Site contains numerous aquatic resources; this AJD is for Wetlands 1, 2, 3, 4, 5, 6, 10, 11 & 12. These wetlands are depressional basins located on an undeveloped lot, as shown on the 2-foot contour map provided in the attached figures (labeled as 2021-01025-MMJ, AJD Figures 1-7). Wetlands 1, 2, 3, 4, 5, 6, 10, 11 & 12 do not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. Based on review of historic and recent aerial photography, The National Wetland Inventory (NWI), USGS topographic maps, and the wetland delineation report submitted by the requestor, we have determined that the wetlands identified above are hydrologically isolated with no surface water connection to a water of the United States (WoUS). These wetlands are not located within a 100-year floodplain. The wetlands are surrounded by non-jurisdictional upland, and there are no swales, ditches, pipes, or other means that would provide a surface or subsurface connection to a WoUS, and these wetlands do not have an ecological connection to a WoUS. The wetland boundaries on this site were verified in the field by local watershed district and state regulatory staff. Regarding Wetland 1 specifically the consultant provided the following additional information: There is upland (a food plot and a field road) between Wetland 1 and offsite private ditches. There were no indications that Wetland 1 drains to the northwest. Wetland 1 is quite dry and the inner lower/depressional contours, which would be the wettest areas, do not appear to have standing water that could drain up and out and offsite. In addition, the Corps previously completed an AJD for the aquatic resources on the property to the west of the subject parcel; the wetlands highlighted in green on the enclosed Figure 2 were determined to be isolated and not jurisdictional (Almberg site Corps #2019-00259-BBY).**

Wetlands 1, 2, 3, 4, 5, 6, 10, 11 & 12 do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not

produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes. Wetlands 1, 2, 3, 4, 5, 6, 10, 11 & 12 are hydrologically and ecologically isolated and the Corps has determined that these wetlands is not regulated by the Corps under Section 404 of the Clean Water Act.
