Explain: **Based on a review of aerial photography, topographic maps, and the wetland delineation report submitted by the requestor, we have determined that these features are isolated wetland depressions with boundaries that transition into uplands. As evidenced on aerial imagery, the wetland signatures observed within the delineated wetland features do not extend outside of the limits of these wetlands and are surrounded entirely by uplands. In addition, the review area has minor changes in elevation, as shown on the USGS topo maps.**

Wetlands 1-3 do not abut any waters and are not separated from one by a natural or man-made feature. The nearest mapped tributary from the review area (Mullet River) is located 0.51 miles southwest of Wetland 3, however, no surface water connections were found linking the wetlands within the review area to the Mullet River.

Wetlands 1-3 do not support links to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Furthermore, the area is hydrologically isolated with no surface water connections to water of the United States. Therefore, the Corps has determined that Wetlands 1-3 are not regulated by the Corps under Section 404 of the Clean Water Act.
