Explain: **The review area for this determination is limited to the boundaries of four roadside ditches labeled as Wet Ditch 1, Wet Ditch 2, Wet Ditch 3, and Wet Ditch 4, on the attached figures labeled 2021-01393-GLH GP & AJD Attachments, Pages 1-4 of 4. The total area of non-jurisdictional waters/features is approximately 0.03 acre.**

**The roadside ditches were constructed in uplands to convey runoff from the adjacent roadway, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WOUS). This was confirmed by reviewing aerial photography, hydric soils, and national wetland and hydrography data provided in the delineation report. Per the Rapanos decision, the evaluated ditches are not WOUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters.**
