Wetland 1	0.31	acre(s)	(b)(1) Non-adjacent wetland.	<p>Based on a review of aerial photography, topographic maps, and the wetland delineation report submitted by the requestor, we have determined that Wetland 1 is an isolated wetland depression with boundaries that transition into uplands. As evidenced on aerial imagery, the wetland signatures observed within the delineated wetland features do not extend outside of the limits of these wetlands and this feature is surrounded entirely by uplands. In addition, the review area has minor changes in elevation, as shown on the USGS topo maps.</p> <p>Wetland 1 does not abut any a(1)-a(3) waters and is not separated from one by a natural or man-made feature. The nearest mapped tributary (tributary to Black Creek) is located 966 linear feet southwest of Wetland 1, with an elevation difference of approximately 8.1 feet, eliminating the likelihood of this feature being flooded in a typical year by an a(1)-a(3) water. In addition, the review area is located outside of the FEMA mapped flood zone of the tributary to Black Creek.</p> <p>Based on this information, we have determined that Wetland 1 is a (b)(1) Non-adjacent wetland, which is not regulated under Section 404 of the Clean Water Act.</p>
