Explain: **In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following activities to be waters of the United States; water filled depressions created in dry land incidental to construction activity. According to the project consultant, construction activities within the last several years have created waterfilled depressions within Wetland 7 and the portion of Wetland 6 outlined on attached map. The Wisconsin Department of Natural Resources has deemed these aquatic resources to be exempt from state regulations based on the same construction activity information. Construction activities began in 2015 on an adjacent building expansion and prior to that aerial imagery showed a lack of wetness signatures, indicating no wetlands within the AJD review area. Grading activities continued within the review area as shown on aerial imagery up until 2019 when the delineation was completed; and by 2021 a graded building pad can be seen. It was this grading activity that led to the creation of Wetland 7 and the narrow, finger like expansion of Wetland 6 located along the new building to the east. The east finger like extension of Wetland 6 and all of Wetland 7, as shown on the attached figure, are not waters of the U.S.**
