Wetland 2, 3, 4, 5	0.77	acre(s)	(b)(1) Non-adjacent wetland.	These features are all isolated wetland basins surrounded by agriculture. Wetlands 2 and 3 are depressional areas within an agricultural field. Wetland 4 extends outside the proposed right of way in a ditch excavated in uplands but flow becomes discrete and appears to end in an area surrounded entirely by uplands. Wetland 5 extends beyond the proposed right of way but does not abut another jurisdictional water. None of the wetlands are inundated by flooding of another jurisdictional water in a typical year and none of the wetlands are separated from a jurisdictional water only by a natural feature.
