- ☒ The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The memorandum submitted by the agent consisted of National Wetland Inventory (NWI), National Hydrography Dataset (NHD), and soil survey information. The NWI and NHD figures did not show any mapped wetland or surface water connection within the review area. The soil survey showed the majority of the site as predominantly non-hydric soils. Two small areas of hydric soils were mapped, however, field review lacked hydrophytic plants within those areas as noted in the submitted memorandum. Based on this information, the review area is not jurisdictional due to the absence of a water of the U.S.
