			Wetland 1 is a National Wetland Inventory (NWI) mapped wetland along the south eastern edge of the project area. The wetland is surrounded by upland as shown on Lidar imagery provided in the delineation report. Additionally, the National Hydrography Dataset (NHD) does not show a surface water connection to an a(1)-a(3) water. The soil survey provided in the delineation report characterized the site as predominantly non-hydric/non-hydric soils. The wetland does have a culvert located on the northern portion of the wetland. The culvert drains from a residential area north of the site, underneath a roadway. Review of Wright County aerial imagery does not show any wet signature or water flow within the culverted area. Based on this information, Wetland 1 is not a water of the U.S. under the Navigable Waters Protection Rule.
