Explain: **The review area includes one aquatic resource (labeled as Ditch 2 on Figure) that is a ditch constructed in uplands prior to 1976. Review of site photos indicates this ditch does not convey a relatively permanent flow and drains only uplands. Additionally, a review of historical aerial photos provided in the delineation report indicates the area involved an agricultural field to the east and open grassy area to the west and does not indicate any wet signatures within the delineated boundaries of the ditch prior to its construction. In accordance with the preamble to the 1986 Corps Regulations (33 CFR Parts 320-330), the Corps does not generally consider the following waters to be waters of the United States; non-tidal drainage ditches excavated on dry land. Further clarification is provided in the December 2, 2008 Revised Guidance on Clean Water Act Jurisdiction following the Supreme Court Decision in Rapanos v. U.S. and Carabell v. U.S. issued jointly by the Corps and EPA which indicates that ditches excavated wholly in and draining only uplands and do not carry a relatively permanent flow are not waters of the United States. Based on this information, Ditch 2 is a non-WOUS which is not subject to Corps jurisdiction under Section 404 of the Clean Water Act, or Section 10 of the Rivers and Harbors Act.**
