B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). The delineation report includes aerial imagery that shows no wetland signatures present on the site. The decision matrix from the Wetland Determination from Aerial Imagery – Recording Form in the delineation determined that field verification was required in several locations. A site visit was conducted and other wetland indicators were not present. Based on the above information, Corps staff concurs with the delineation report findings that the AJD Review Area consists entirely of uplands.
