Explain: **The review area for this jurisdictional determination includes 41 roadside ditches labeled as Wetlands 6, 7, 8, 14, 15, 16, 17, 18, 19, 20, 21, 22, 25, 26, 27, 28, 29, 30, 31, 32, 33, 36, 37, 41, 43-1, 43-2, 43-5, 43-6, 45-1, 45-2, 45-5, 46, 47, 48, 49, 51-5, 54, 55, 56, 57, and 60 on the attached figures labeled 2021-01763-BGO Figures 1-18 of 18. The total area of non-jurisdictional waters/features is approximately 2.24 acres.**

The roadside ditches were constructed in uplands to convey runoff from the adjacent roadway, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WoUS). This was confirmed by reviewing aerial photography, hydric soils, and national wetland and hydrography data provided in the wetland delineation report. Per the Rapanos decision, the assessed ditches are not WoUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters.
