#### **SECTION II: SUMMARY OF FINDINGS**

#### A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Based on a review of historic aerial photography, topographic maps, and the wetland delineation report submitted by the requestor, we have determined that Wetlands 3 and 4 are isolated wetland depressions with boundaries that transition into uplands. As depicted in aerial imagery, the wetland signatures observed within the delineated wetland features do not extend outside of these wetlands and are surrounded entirely by agricultural uplands. In addition, the review area has minor changes in elevation, as show in the USGS topo maps.

Wetlands 3 and 4 do not abut and are not separated from any waters of the U.S. by natural or man-made features. The nearest mapped tributary is the North Branch of Ashwaubenon Creek located approximately 813 feet north of Wetland 3. Historical aerial photography depicted minor wet signatures in the immediate areas, however, no surface water or ecological connections are present that link these wetlands to this tributary or other aquatic resources. Based on this information, Wetlands 3 and 4 are ecologically separated from all other aquatic resources.

These aquatic resources do not support a link to interstate foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined these aquatic features are not regulated by the Corps under Section 404 of the Clean Water Act.
