Explain: **This AJD is limited to the boundaries of Stormpond 1 (S1). S1 is a constructed stormwater pond located along the northwestern boarder of the site. The pond extends offsite to the parcel to the north. Review of the National Wetlands Inventory (NWI) does not denote the wetland and the National Hydrography Dataset (NHD) does not show a surface water connection to a Water of the U.S. (WoUS). Additionally, the 2-foot LiDAR contours in the delineation report show that S1 is surrounded by uplands. The report also noted that the stormpond was constructed in upland for a development in 2001, however, the development did not occur and no inlet or outlet structures were installed in the stormpond. The preamble of the 1986 Regulations of 33 CFR Parts 320 through 330, with respect to the interpretation of the definition of WoUS given by 33 CFR 328.3, that ponds created in dry land or retain water and used for purposes such as settling basin are generally not intended to be considered WoUS. Therefore, S1 is not a WoUS, and is not jurisdictional under the CWA.**
