Explain: **The review area contains one wetland, labeled W-1 (0.76 acre). This wetland is isolated, per review of the October 2021 wetland delineation report by raSmith, which included USGS topography, an NRCS hydric soils map, Wisconsin Wetland Inventory, Waukesha County 1-ft contours, aerial photographs, and ground level site photos. The 1-foot contours clearly show a shallow depression at elevation 830' in a farm field surrounded by higher upland. The wetland is constrained to the west by a residential neighborhood. Aerial photos show that the wetland is farmed around on three sides every year. There are no visible inlets or outlets that connect W-1 to any downstream waters. The nearest tributary is the Fox River, approximately 0.38 mile to the south.**

This wetland does not border, is not neighboring to or contiguous with another water of the US. It is not separated from another water of the US by man-made barriers, dikes, or berms. Due to existing and surrounding land use (upland agricultural field and residential neighborhood) and proximity to other waters, there are no ecological connections to other wetlands or waters. This aquatic resource does not support a link to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-1 is not regulated by the Corps under Section 404 of the Clean Water Act.
