Explain: **The review area contains two wetlands, labeled W-3 (0.01 acre) and W-4 (0.04 acre). These wetlands are isolated, per review of the 2018 delineation report by Davel, which included NRCS hydric soils, Wisconsin Wetland Inventory, historic aerial photographs, ground level site photos, and 1-foot contours. Both wetlands are situated in farmed depressions around elevation 692' surrounded by upland agricultural field. There are no observable inlets or outlets associated with either wetland and no surface or shallow subsurface connections to a downstream water. The nearest tributary is the Fox River, approximately 0.6 miles to the east.**

These wetlands do not border, are not neighboring to or contiguous with another water of the US. They are not separated from another water of the US by man-made barriers, dikes or berms. Due to existing and surrounding land use (agricultural development) and proximity to other waters, there are no ecological connections to other wetlands or waters. These aquatic resources do not support a link to interstate or foreign commerce; are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined that W-3 and W-4 are not regulated by the Corps under Section 404 of the Clean Water Act.
