Explain: **Based on a review of aerial photography, topographic maps, and the wetland delineation report submitted by the requestor, we have determined that Wetland W1 is an isolated wetland depression with boundaries that transition into uplands. As depicted in aerial imagery, the wetland signatures observed within the delineated wetland feature does not extend outside of the wetland and is surrounded entirely by uplands. In addition, the review area has minor changes in elevation, as show in the USGS topo maps.**

Wetland W1 does not abut and is not separated from any waters of the U.S. by natural or man-made features. The nearest (a)(1)-(a)(3) water is Lake Winnebago located approximately 0.61 mile to the east of the review area. Historical aerial photography depicted no wet signatures in the immediate areas, demonstrating no surface water or ecological connections are present that link Wetland W1 to this water or other aquatic resources.

This aquatic resource does not support a link to interstate foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Therefore, the Corps has determined this aquatic feature is not regulated by the Corps under Section 404 of the Clean Water Act.
