- ☒ Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **This AJD is limited to the boundaries of Wetland 1. Wetland 1 is a constructed stormwater basin that was constructed between 1964 and 1979, as shown on historic aerials submitted in the wetland delineation report. Historic USGS topographic maps do not map the area as wetland and soils maps also reflect this finding. The area is predominantly mapped in non-hydric soils with a small portion mapped in predominantly hydric soils. Historic aerial imagery was reviewed and appeared to show faint wet signature that extended out from a nearby wetland basin but was not conclusive for the constructed Wetland 1 area. Proposed grading information was submitted by the agent that included detailed survey information. The survey lines detailing current site conditions show that Wetland 1 is surrounded by upland, which supports that the stormwater pond was constructed in upland.**

The preamble of the 1986 Regulations of 33 CFR Parts 320 through 330, with respect to the interpretation of the definition of WoUS given by 33 CFR 328.3, states that ponds created in dry land to retain water and used for purposes such as settling basins are generally not intended to be considered WoUS. Therefore, Wetland 1 is not a WoUS, and it is not jurisdictional under the CWA.
