Explain: **The review area contains one delineated wetland, which is identified as Wetland 3 (0.2-acre). The delineation report describes Wetland 3 as a wet meadow that is located in the middle of an agricultural field and has been disturbed by on-going farming practices. In our review of the Wisconsin Wetland Inventory and the Dane County Soil Survey, there are no mapped wetlands or mapped hydric soils at the location of Wetland 3 and the nearest waterway is a tributary to the Yahara River approximately 400 feet northeast of this wetland. In addition, the topographic map shows Wetland 3 is located in a low flat area in the landscape and there were no visible wet signatures that would indicate a hydrologic connection from Wetland 3 to another wetland or waterway in the off-site aerial photo analysis. The delineation report determined that there are upland soils surrounding Wetland 3 and there are no man-made dikes, berms, or barriers separating Wetland 3 from other waters of the U.S. In addition, Wetland 3 does not support a link to interstate or foreign commerce, is not known to be used by interstate or foreign travelers for recreation or other purposes, does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce, and is not known to be used for industrial purposes by industries in interstate commerce. Based on these factors, the Corps has determined that Wetland 3 is an isolated wetland that does not have a hydrologic connection to an RPW or TNW and is not a water of the United States subject to Corps regulation under Section 404 of the Clean Water Act.**
