This application is being reviewed in accordance with the practices for documenting Corps jurisdiction under Sections 9 & 10 of the Rivers and Harbors Act of 1899 identified in Regulatory Guidance Letter 16-01.

**PROJECT DESCRIPTION AND PURPOSE:** Michels Corporation is requesting Department of the Army authorization to establish a new barge fleeting operation on the decommissioned Dairyland Power Cooperative property at 1078 Jack Oak Rd, Cassville, WI 53806. The purpose of the project is to provide a staging area for Michels Corporation's River Construction Division to manage material barges, tugs, and dredging equipment. Michels Corporation intends to utilize the existing barge landing pad and four dolphin mooring structures; No modifications to these structures are proposed. The fleeting operation area would include a 105' wide by 800' long footprint to allow for up to 12 barges (Approximately three barges wide by four barges long) to be moored at this location. The proposed project would not result in the discharge of dredged or fill material into waters of the U.S. Additionally, no dredging, hydraulic spud systems or other disturbance to the riverbed is proposed to initiate barge fleeting operations. There would not be a loss of waters of the U.S. and the Mississippi River would continue to provide normal river functions.


**THREATENED OR ENDANGERED SPECIES:** This notice is being coordinated with the U.S. Fish and Wildlife Service (USFWS). Any comments USFWS may have concerning Federally listed threatened or endangered wildlife or plants or their critical habitat will be considered in our final assessment of the described work. Any Section 7 consultation, if required, will conducted independent of this notice.

**TRIBAL TRUST OR OTHER RESOURCES:** The Corps will review information on known cultural resources and/or historic properties within and adjacent to the project area. The Corps will also consider the potential effects of the project on any properties that have yet to be identified. The results of this review and the Corps' determination of effect will be coordinated with the State and/or Tribal Historic Preservation Officer independent of this public notice. Any adverse effects on historic properties will be resolved prior to the Corps authorization of the work in connection with this project.

**COMPENSATORY MITIGATION:** The applicant has not proposed any compensatory mitigation because there would not be a permanent loss of waters of the U.S. Additionally, the applicant would implement the necessary BMPs (i.e., silt fencing) to prevent secondary effects to water quality during the construction phase of the project.






