A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

 - Explain: This AJD is limited to the boundary of Wetland 3. This boundary is shown on the attached figures labeled, "MVP-2007-02154-ACM, AJD Attachments, Pages 1-2 of 2". Based on the report submitted by the requestor, aerial imagery, including LiDAR contours, we have determined that Wetland 3 is isolated. Wetland 3 is located in an isolated depression, surrounded by uplands. The adjacent uplands drain into Wetland 3. The polygon labeled Area D was investigated, to determine if there was a connection between Wetland 1 and Wetland 3. After review of Area D, Wetland 3 does not have a surface water connection or known shallow subsurface connection to downstream waters. The nearest tributary is Sarah Creek, which is approximately 0.7 miles southwest of Wetland 3. Wetland 3 is not located in a floodplain. Wetland 3 is surrounded by single family residential homes, cropped fields, farmsteads, and roads. There are no culverts, tile lines, or inlets/outlets connected to Wetland 3.

Wetland 3 does not support links to interstate or foreign commerce; is not known to be used by interstate or foreign travelers for recreation or other purposes; does not provide fish or shellfish that could be taken and sold in interstate or foreign commerce; and is not known to be used for industrial purposes by industries in interstate commerce. Wetland 3 does not have an ecological connection to a water of the United States. Therefore, the Corps has determined that Wetland 3 is not regulated by the Corps under Section 404 of the Clean Water Act.
