MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023), 1 MVP-2022-00046-JMK MFR 1 of 1

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States," 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

The review area is located at 43.9510 N, -92.3580 W in the City of Rochester, Olmsted County, Minnesota. There are no other JDs associated with the review area.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

 - Wet Ditch 1 (1.53 acres), Wet Ditch 6 (0.19 acre), Wet Ditch 9 (0.45 acre), Wet Ditch 11 (0.27 acre), and Flow Path B (0.01 acre) within the review area are linear roadside drainage ditches constructed in upland and drain only upland based on a review of US Geological Service 3DEP Hill shade and DEM maps; MNDNR 2-foot contour maps; NWI maps; NHD data; and NRCS hydric soil data. Recent aerial photos and photos submitted as part of the permit application do not show relatively permanent flow in the aforementioned aquatic resources. Based on the desktop resources reviewed Wet Ditch 1, Wet Ditch 6, Wet Ditch 9, Wet Ditch 11, and Flow Path B are linear roadside drainage ditches constructed in upland. Therefore, Wet Ditch 1, Wet Ditch 6, Wet Ditch 9, Wet Ditch 11, and Flow Path B have been determined to be Paragraph (b)(3) excluded ditches and not subject to Section 404 of the Clean Water Act (CWA).




Figure 1 Resource Impacts
