MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ MVP-2022-01980-MJG, MFR 1 of 1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

3. REVIEW AREA. The review area is limited to Wetland 1, Wetland 2, Wetland 4, and Wetland 6, as identified by the blue polygons in the enclosed figures labeled MVP-2022-01980-MJG AJD Page 2 of 3. The review area is located at 19330 County Road 30 (Parcel ID 12-119-23-130-007) in Section 12, Township 119 North, Range 23 West, City of Corcoran, Hennepin County, MN. (Lat: 45.132868, Long: -93.527345). The review area is surrounded by agricultural fields, residential development, and roadways. There are no other jurisdictional determinations associated with the review areas.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

- a. Describe aquatic resources and other features within the review area identified in the 2023 Rule as amended as not “waters of the United States” even where they otherwise meet the terms of paragraphs (a)(2) through (5). Wetland 1, Wetland 2, Wetland 4, and Wetland 6 are not TNWs, territorial seas, or intrastate waters, and therefore, are not (a)(1) waters. Wetland 1, Wetland 2, Wetland 4, and Wetland 6 do not physically abut a paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary.

The National Wetlands Inventory (NWI) maps, topographic maps, and National Hydrology Dataset (NHD) maps display Wetland 1, do not display Wetland 2, Wetland 4, or Wetland 6, and do not show any tributaries that abut these wetlands. Based on LiDAR data, the NWI map, and topo maps, Wetland 4 and Wetland 6 are depressional agricultural wetland that does not abut a tributary and is surrounded by upland. East of Wetland 2, there is a culverted connection to Wetland 1. Wetland 1 appears to flow south under CTY 30 to a larger offsite wetland. LiDAR data, the NWI map, and topo maps show Wetland 2 and Wetland 1 as a depressional basin surrounded by upland that rises in elevation from 1-6 feet. LiDAR data, the NWI map, and topo maps do not show this wetland as being part of any larger wetland that may be connected to a tributary. The closest tributary based off of desktop resources is South Fork Rush Creek located approximately 0.83 miles east of the review area.

Wetland 1, Wetland 2, Wetland 4 and Wetland 6 do not abut a relatively permanent water, and as such, cannot be evaluated as (a)(4) adjacent wetlands. Therefore, Wetland 1, Wetland 2, and Wetland 6 are not jurisdictional under the

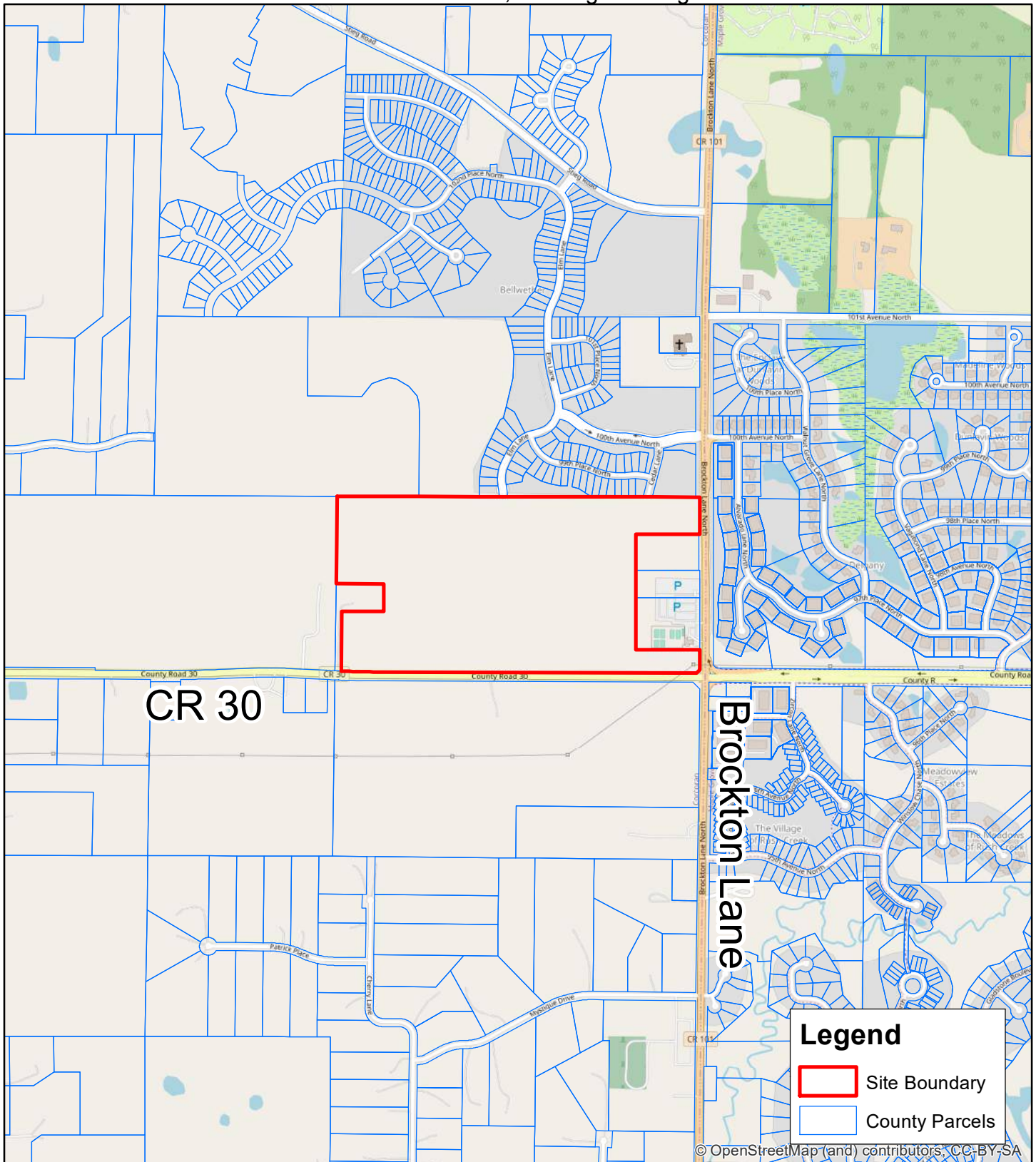


Figure 1 - Site Location

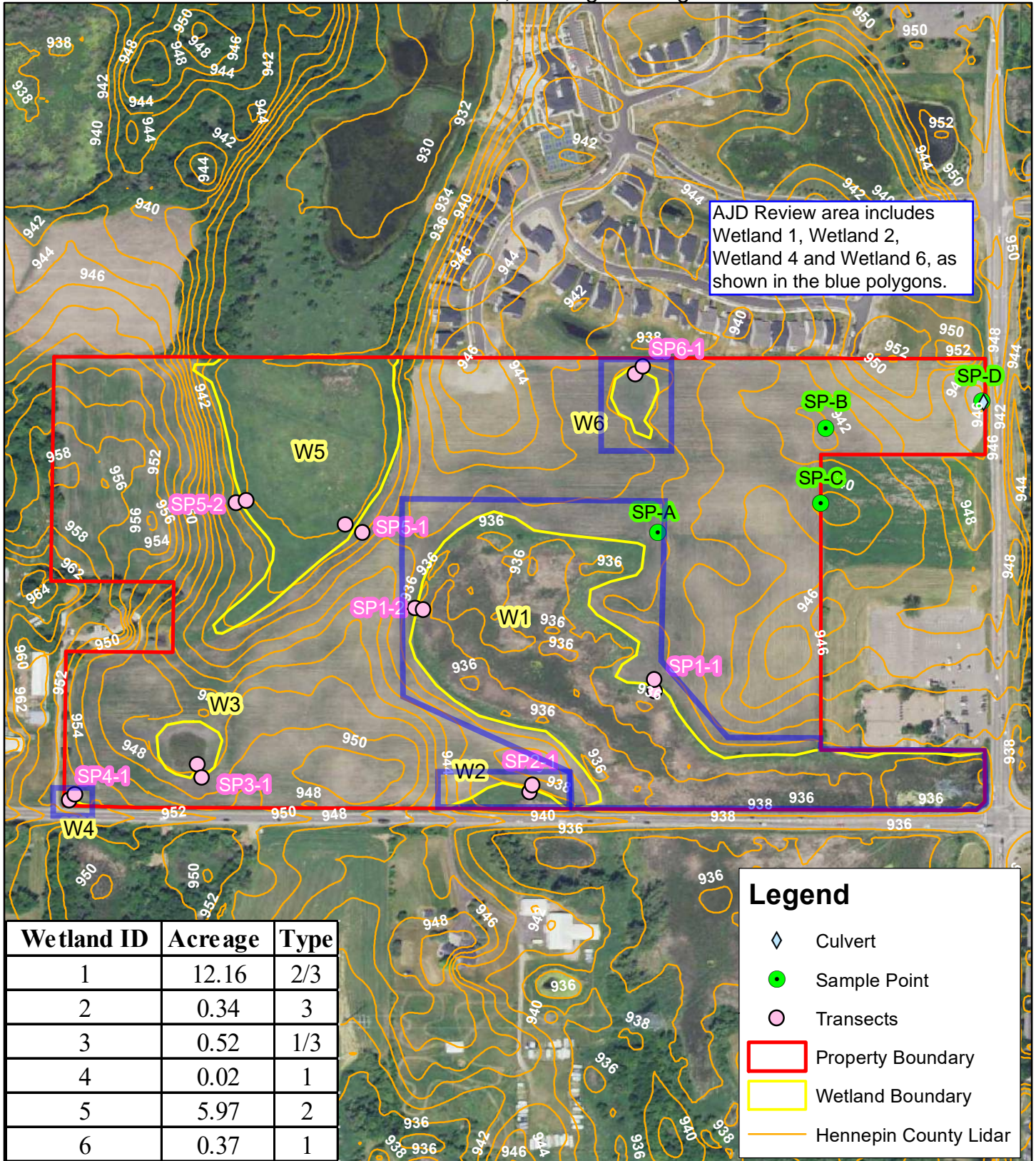


Figure 2 - Existing Conditions (2021 FSA Photo)
