MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ MVP-2023-01568-BCB (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the 2023 Rule as amended,

3. REVIEW AREA. The features within the review area include two wetlands identified in Section 1(a) of this MFR and within the red polygons as shown on the attached figures labeled MVP-2023-01568-BCB: Pages 1 – 4 of 4. The review area is located at latitude 45.429404 N; longitude -93.818896 W, Sherburne County, Minnesota. There are no other JDs associated with the review area.

8. NON-JURISDICTIONAL AQUATIC RESOURCES AND FEATURES

- a. Wetlands 2, and 6 are not TNWs, territorial sea, or interstate water and therefore are not an (a)(1) water. National Regulatory Viewer: USGS 3DEP map and hill shade, indicate that wetlands 2 and 6 are depressional wetlands, surrounded by upland. A delineation was submitted to the USACE on December 6, 2023, depicting the wetland boundaries within the project area. The Local Government Unit, under the authority of the Minnesota Wetland Conservation Act, also reviewed the delineation and agreed with the delineated wetland boundaries. Wetlands 2 and 6 appear to extend outside the property boundaries. The NRV elevation profile tool and contours depict that the wetland 6 is depressional. A culvert is present next to wetland 6 but is at a higher elevation disconnecting the continuous surface connection. Wetland 2 is present on the NWI layer, but the delineation submitted to the USACE separates the wetland from extending further south and west. The wetland may extend past the project boundaries but the USGS 3DEP map and hill shade, indicate that wetland 2 is a depressional wetland with no outlet. The wetlands do not physically abut a relatively permanent paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary and is not separated from a jurisdictional water by a natural berm, bank, dune, or similar natural landform. The wetlands are over a mile east of the Elk River, a tributary to the Mississippi River. However, there are no ditches, swales, pipes, or culverts that connect these wetlands to downstream jurisdictional waters. Wetlands 2 and 6 are non-tidal wetlands that do not have a continuous surface connection to a relatively permanent jurisdictional water and as such do not meet the definition of adjacent and cannot be evaluated as (a)(4) adjacent wetlands; therefore, the wetlands are not jurisdictional under the 2023 Revised Definition of

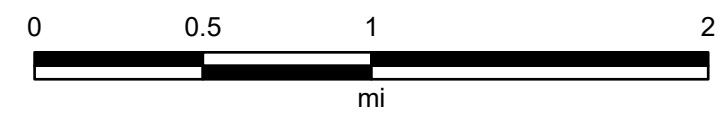

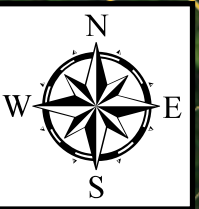

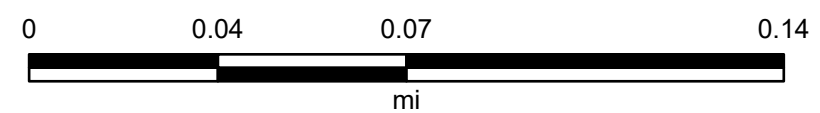

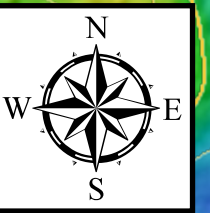

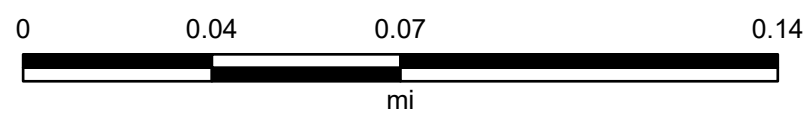
