MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ MVP-2024-00223-MWM, MFR 1 of 1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

The 10-digit HUC code that the review area is within is the Fish Trap Creek watershed, HUC: 0701010806

The features within the review area include Wet Ditch 14-16, and 18-21, as shown on the attached figures labeled MVP-2024-00223-MWM, which are excluded waters. The features meet the definition of a b(3) water as they were created by excavating dry land and the features drain only dry land and they don't carry relatively permanent flow, nor are they relocated tributaries.

The wet ditches are linear drainage features constructed adjacent to County State Aid Highway (CSAH) 1 (Dove Road). In a review of a 1992 aerial photo from Google Earth, the alignment and existing location of the ditches appear to be the same as reported by the applicant. Other resources reviewed to support this determination include MNDNR Hillshade – 2016, National Wetland Inventory, USA Soils Map, and USA Soils Hydric Class on the National Regulatory Viewer (NRV).

Considering the information above, these features have been determined to each be a Paragraph (b)(3) excluded ditch and not subject to Section 404 of the Clean Water Act (CWA).
