MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Approved Jurisdictional Determination in accordance with the "Revised Definition of 'Waters of the United States'"; (88 FR 3004 (January 18, 2023) as amended by the "Revised Definition of 'Waters of the United States'; Conforming" (8 September 2023) ,¹ MVP-2025-00474-MJG MFR 1 of 1.

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.² AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.³

On January 18, 2023, the Environmental Protection Agency (EPA) and the Department of the Army ("the agencies") published the "Revised Definition of 'Waters of the United States,'" 88 FR 3004 (January 18, 2023) ("2023 Rule"). On September 8, 2023, the agencies published the "Revised Definition of 'Waters of the United States'; Conforming", which amended the 2023 Rule to conform to the 2023 Supreme Court decision in *Sackett v. EPA*, 598 U.S., 143 S. Ct. 1322 (2023) ("*Sackett*").

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. For the purposes of this AJD, we have relied on Section 10 of the Rivers and Harbors Act of 1899 (RHA),⁴ the 2023 Rule as amended, as well as other applicable guidance, relevant case law, and longstanding practice in evaluating jurisdiction.

3. REVIEW AREA. The review area is limited to Wetland 1 as identified by the blue polygon in the enclosed figures labeled 2025-00474-MJG AJD Figures, Page 2 of 2. Wetland 1 is located at Lat: 45.16184987, Long: -93.46609251. The review area is located in Section 33, Township 120 North, Range 22 West, Hennepin County, Minnesota. The surrounding upland area consists of agricultural land, residential development, and roadways. There are no other JDs associated with the review area.

Wetland 1 is not a TNW, territorial sea, or intrastate water, and therefore, is not an (a)(1) water. Wetland 1 does not physically abut a paragraph (a)(2) impoundment or a jurisdictional (a)(3) tributary. The National Wetlands Inventory (NWI) does not display wetlands within the review area. The National Hydrography Dataset (NHD), USGS topographic maps, and aerial maps do not show any tributaries that abut Wetland 1. Based on aerials and topographic, hillshade, and elevation modeling mapping, this wetland is depressional, surrounded by upland, and does not abut a tributary. The closest tributary is an unnamed stream located approximately 0.34 miles southeast of Wetland 1. Wetland 1 does not abut a relatively permanent water, and as such, cannot be evaluated as an (a)(4) adjacent wetland. Therefore, Wetland 1 is not jurisdictional under the 2023 Revised Definition of ‘Waters of the United States’: Conforming 88 FR 61964 Final Rule.

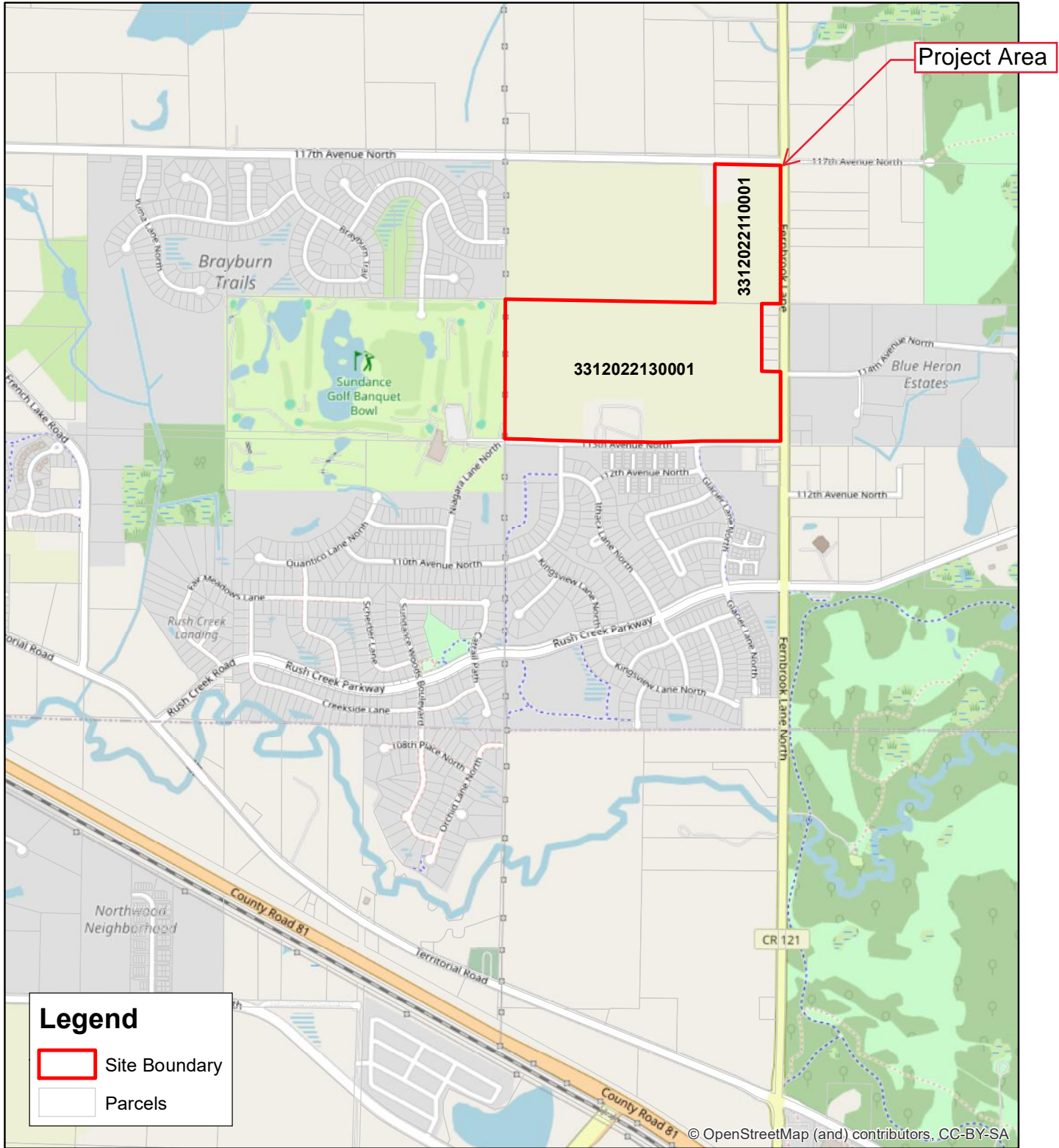


Figure 1 - Site Location

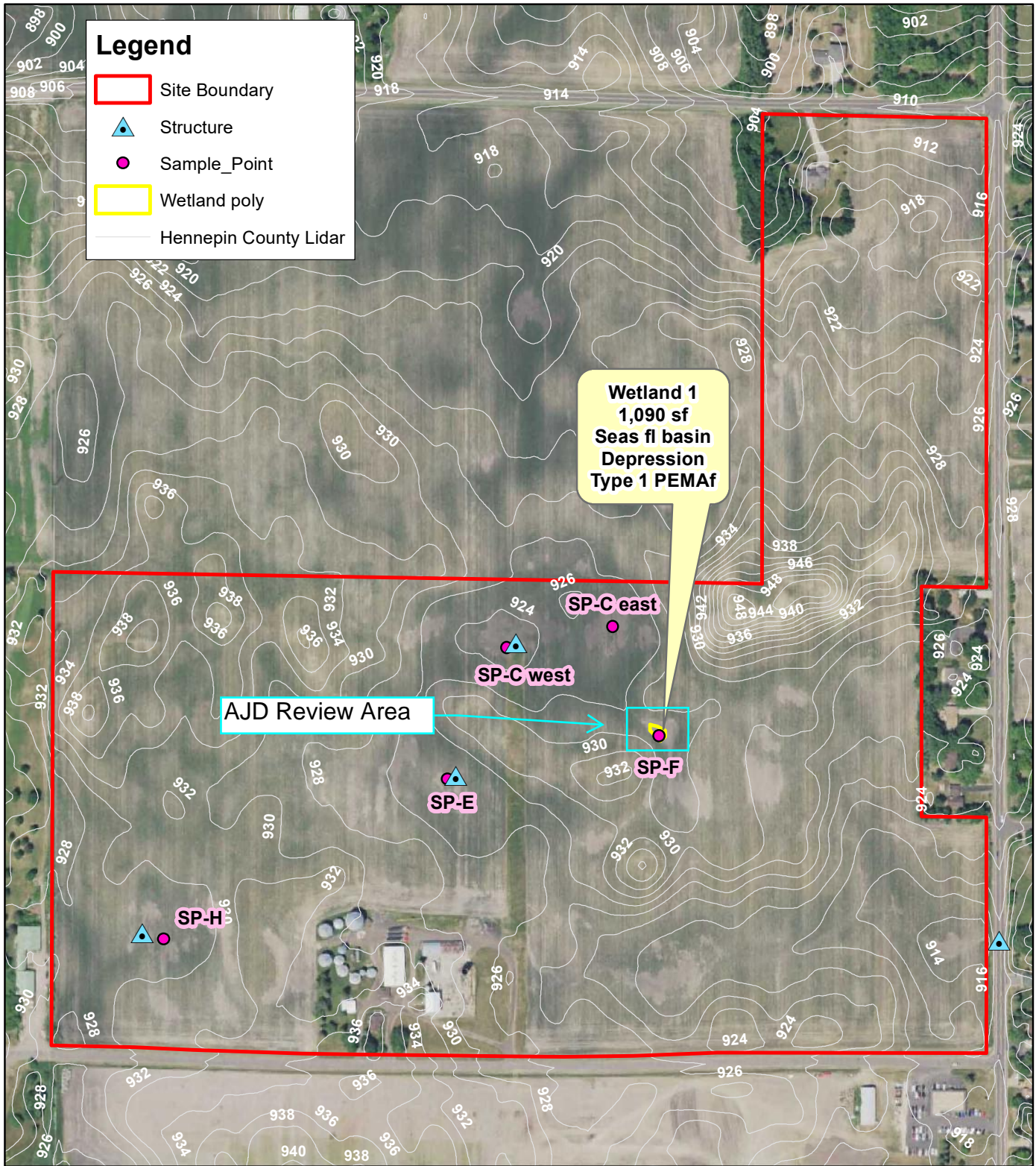


Figure 2 - Existing Conditions (6-18-2021 FSA Photo)
