There are no "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area.

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are six wetlands within the project boundaries, Wetland 1 through Wetland 6, shown on the enclosed figures labeled MVP-2015-02483-BBY Page 1 of 2 through 2 of 2; however, this AJD is only for wetlands 2 & 3. Wetland 2 and Wetland 3 were classified as PEM1Af wetlands with Type 1 Seasonally Flooded Basin characteristics. Both wetlands are bordered by cropland, with boundaries following a distinct line of soybeans. Wetlands 2 and 3 are depressional basins that both lack a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. There are no swales, pipes, or other means to connect Wetland 2 or Wetland 3 to waters of the U.S. (WOUS). We have determined that this Wetland 2 and 3 are isolated depressions and not waters of the U.S.

Wetlands 2 and 3 within the project boundaries do not support a link to interstate or foreign commerce because they are not known to be used by interstate or foreign travelers for recreation or other purposes; do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce; and are not known to be used for industrial purposes by industries in interstate or foreign commerce. Wetlands 2 and 3 do not have an ecological connection to other waters within the review area. Wetlands 2 and 3 were determined to not be jurisdictional under the CWA.
