<u>D. ADDITIONAL COMMENTS TO SUPPORT JD</u>: The review area for this determination contains four roadside ditches labeled as Basin B2, Basin B3, Basin B5, Basin 8A, Basin B12, and Basin B13 on the attached figures labeled AJD MVP-2018-02130-BBY Page 1 of 3 through Page 3 of 3. The total size of non-jurisdictional ditches is approximately 0.55 acre. The ditches are constructed features that are not relocated tributaries, are not excavated in a tributary, and do not convey perennial or intermittent flow. This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation report dated May 29, 2018. Based on this review, the evaluated ditches are not jurisdictional under the 2015 Clean Water Rule because they meet the terms of paragraph (b)(3)(i)..
