D. ADDITIONAL COMMENTS TO SUPPORT JD: The site contains 5 wetlands. This determination is only for wetland 1 and wetland 5. The agent submitted appropriate documentation in the delineation report and subsequent
application to determine wetland 1 was constructed as part of a wastewater system in 2015. The NPDES permit site

ID is C00040950. Wetland 5 formed as the result of the deconstruction and demolition of the greenhouse on site. Wetland 5 is a water-filled depression created in dry land incidental to construction activity and is not a water of the United States.

The wetland has no surface or subsurface connection to a water of the United States and does not have an ecological connection due to the existing disturbance. Wetland 5 is not a WoUS and is not jurisdictional under the CWA.
