Explain: **The review area for this determination is limited to the boundaries of 34 roadside ditches labeled as Wet Ditch #1-2, #4, #6-9, #11, #13-14, #22-26, #45-48, #50-51, #58-66, #75, #82, #83B, and #86 on the attached figures labeled 2019-02101-BGO MnDOT SP 4609-17/TH 263 AJD Attachments, Pages 1-20 of 20. All of the labels for these aquatic resources are also highlighted in yellow on the attached figures. The total area of non-jurisdictional ditches is approximately 5.28 acres.**

The roadside ditches were constructed in uplands, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (WOUS). This was confirmed by reviewing aerial photography, national hydrography data, and the wetland delineation report. Per the Rapanos decision, the evaluated ditches are not WOUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters.
