The roadside ditch was constructed in upland, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (Wo US). Per the Rapanos decision, the evaluated ditch is not WoUS because it is not a tributary and does not have a significant nexus to traditionally navigable waters. This was confirmed by reviewing aerial photography and information provided in the January 2020 Joint Application.
