Explain: **The review area for this determination contains 5 roadside ditches labeled as Wetland 3, Wetland 6, Wetland 7, Wetland 10, and Wetland 11 on the attached MVP-2019-03041-JRH AJD Attachments Page 3 of 3.**

The roadside ditches were constructed in uplands, drain only uplands, and do not carry a relatively permanent flow of water into waters of the U.S. (Wo US). Per the Rapanos decision, the evaluated ditches are not WoUS because they are not tributaries and do not have a significant nexus to traditionally navigable waters. This was confirmed by reviewing aerial photography and the wetland delineation report dated December 2019.

Please note that the remainder of the aquatic resources shown on the attachments have been addressed in other jurisdictional determinations.
